Roof Rack System Email Sweepstakes
Official Rules

NO PURCHASE NECESSARY TO ENTER

Eligibility: Only legal U.S. residents 18 years of age or older are eligible to enter the "Roof Rack System Email Sweepstakes" ("Sweepstakes"). Void where prohibited by law. The following persons are not eligible to enter the Sweepstakes: Employees, officers and directors of Yakima Products, Inc. ("Sponsor") and Sponsor's affiliated companies, subsidiaries, suppliers, vendors, representatives, distributors, advertising agencies, and promotional suppliers (collectively, "Sponsor Affiliates"), and members of the immediate families and/or persons living in the same household as the foregoing individuals.

Sweepstakes Period: This Sweepstakes begins on March 24, 2016 at 12:00:01AM PST and ends on June 24, 2016 at 11:59:59PM PST ("Sweepstakes Period"). Sponsor's computer, or its third party service provider's computer, is the official timekeeping device for the Sweepstakes.

A winner will be chosen through a random drawing (as discussed below) from all Entries received during the Entry Period.

How to Enter:

(a) ENTER VIA WEBSITE: Enter via Sponsor's website by going to www.whispbar.com, completing the contest information form on the "home page pop up form" (the "Home Page"), completing the entry form available on the Home Page and completing all required actions, including all required fields and submitting the form.

Entries containing false or fraudulent information will be disqualified. Limit one (1) entry per person during the Sweepstakes Period, regardless of the form of entry. Duplicate entries for a single individual during the Sweepstakes Period will be disqualified. Odds of winning depend on number of eligible entries received during the Sweepstakes Period. Entries remain the property of Sponsor and will not be returned or acknowledged.

All information collected through entry into the Sweepstakes will be used only in accordance with Sponsor's privacy notice at: <http://www.whispbar.com/about/privacypolicy/>.

Prize: The winner of the Sweepstakes will receive one (1) Whispbar Roof Rack System (estimated retail value \$549). No substitute, transfer, or cash equivalent for the prize is allowed by the winner.

Drawing and Notification: The Sweepstakes prize winner will be selected in a random drawing, after the Sweepstakes Period, from all eligible entries received during the Sweepstakes Period. The results of all drawings, and the decisions of Sponsor and its third party service providers, are final and binding in all respects. The winner will be notified by email or first class mail, to the email address or mailing address provided with entry, within five (5) business days after the prize drawing. If a potential winner cannot be reached at the address provided and does not respond to Sponsor (or its third party service provider) within ten (10) days from receipt of the prize notification, or if he/she is found to be ineligible, or if he/she cannot or does not otherwise comply with these Official Rules, an alternate winner will be selected by a second chance random drawing.

Consent to Receive Email: By participating in the Sweepstakes, you will opt-in to receive email or other communications from Sponsor and its affiliated partners. You may subsequently opt-out of the receipt of such email or communications by following the directions in the email or contacting that site. Your opt-out status will not affect your participation or chances to win in the Sweepstakes. During the Sweepstakes Period, however, you may nevertheless receive emails which Sponsor deems are related to the Sweepstakes and related programs.

General Conditions: All Federal, state and local laws and regulations are applicable. sole discretion, reserves the right to suspend, cancel or modify the Sweepstakes, without liability.

Sponsor is not responsible for its own, its third party service provider's, or any entrant's computer system, hardware, software or program malfunction or other errors, failures, delayed computer or email transmissions or network connections that are either human or technical in nature.

This Sweepstakes is void where prohibited, restricted or taxed by law.
